Exploring the Practical Path of Ecological Moral Education for College Students in the New Era based on Labor Education

3.3. Create a Harmonious and Green Campus Labor Culture Atmosphere

According to the educator Sukhomlinsky, the art of education lies in using the environment, the scene around the students themselves and everything in the rich collective life for education. The first step of ecological moral education in colleges and universities is attaching importance to optimizing the campus environment [7]. By setting up special columns and releasing multiform theme propaganda on official websites, WeChat public numbers, E-Class and other platforms, the university creates a good public opinion atmosphere for labor education propaganda. Emphasizing giving full play to the cultural and educational function of school library and school history museum, the school conducts on-site visits and studies, lectures and special exhibitions to guide teachers and students to participate in the study and publicity of labor culture. Moreover, combined with the major situation needs for Rural Revitalization and COVID-19 prevention and control in the new era, the university actively excavates and set up the deeds of the role models around students. What's more, giving full play to the leading role by example and peer education of the advanced backbone of students, vigorously creating a good campus labor atmosphere, cultivating teachers and students' labor concept, and enhancing their civic, social and service awareness.

3.4. Establish Coordination and Joint Protection Mechanism and Measures

The school and college specifically set up a labor education-working group to do top-level design and guidance, study and formulate school labor education-related policies and systems, and coordinate and promote the development, evaluation and supervision of labor education. Schools should play their functions, combine the goals of ecological moral education with the characteristic positioning of colleges and universities, and actively lead the construction of courses and teachers for ecological moral education. Families should cooperate with the requirements of the school and students' ecological moral literacy improvement, and strive to form a harmonious ecological family environment so that students can establish a correct outlook on life, values and ecology in their daily lives. Society, especially enterprises, is an important base for the ecological experience of college students. Building a good socialecological environment, and forming a positive ecological moral atmosphere will directly affect college students' ecological moral level. In addition, the internet is the gathering place for college students' life and growth in the new era. We should strengthen college students' online moral education and the construction of the network ecological culture. Furthermore, playing the role of new media supervision and propaganda, enriching ecological moral culture, enhancing the interest and attraction of communication, making ecological moral consciousness penetrate the hearts of college students, and forming a good college ecological environment.
